- Operator RFP
  - Current Contract includes the following:

 System Operator (0.1 FTE)
 \$10,000

 Center Leadership (0.25 FTE)
 \$25,000

 Staffing of Centers (2 FTE)
 \$90,000

 \$125,000

• The new RFP will require rescinding the current RFP effective July 1, 2018 in the amount of \$51,000 for staffing of the centers.

- It was recommended that the RFP be separated into components: Leadership and staffing.
  - ✓ Leadership increased to 40 hours
  - ✓ Staffing would include the following:

Elmira: up to 40 hoursMontour Falls: 40 hours

• Bath: 40 hours

• Hornell: up to 20 hours

- It was recommended to increase the funding to attract a dynamic, experienced leader. RFP will include expectation of staffing and leadership (high-functioning, independent, self-starter).
- RFP A: Leadership (\$100,000) RFP B: Staffing (\$210,000) RFP C: Combined (\$310,000). This format will allow for a choice of either Leadership or Staffing if not interested in both.
